The nomination forms can be obtained free of cost from above mentioned venue from 11.00 AM to 04.00 PM on 15.12.2020. Nomination forms duly filled along with Rs.1000/- IN CASH AS SECURITY DEPOSIT should be handed over to the undersigned personally by the candidate or proposer or seconder on the date and time mentioned above. A Person shall not be eligible to contest election for two posts simultaneously. In case member is nominated for two seats, the member shall intimate his final choice to contest on one seat on the date of withdrawal, failing which his both nomination papers shall be deemed to have been cancelled. Further, the candidate, proposer & seconder should not be defaulter. **A member shall not be eligible to contest for the election, if he has not completed minimum period of one year from the date of acquiring membership in the society to the date of filing of nomination and he must have attained the age of 21 years.** In case the candidate gets less than 1/6 of the total votes polled, the security deposit shall be forfeited and such candidates shall be disqualified for contesting the election in the society for a period of two terms.

Not more than three members (including President & Vice President) can be elected to the Managing Committee from one Ministry and its subordinate Office/Department.

The list of members of the aforesaid society shall be displayed at the O/o the undersigned and at the O/o Govt. Employees (Urban) Coop.
